NB: You are required to submit this form by the above deadline even if you are planning to register for non-attendance for the first academic year due to compulsory military or civil service, childbirth or health reasons.

CONDITIONS OF THE SCHOLARSHIP

In connection to being admitted to an international degree programme at the University of Jyväskylä, you have been awarded a scholarship, which covers 50% of the tuition fee in your programme.

The scholarship was tentatively awarded to you for the target degree completion time (three academic years for bachelor's studies and two academic years for master's studies). To receive the scholarship for the second academic year (and for the third year in the case of a Bachelor's programme), you must make sufficient progress in your studies. This means that you must complete a minimum of 55 ECTS credits that can be included in your degree during the previous academic year in order to qualify for the JYU Scholarship for the following year. If you have been admitted to the Bachelor of Business Innovation and Sustainability programme and continue your study path to a master's degree, you'll be granted the JYU Scholarship for the master's studies as well, on the condition that you complete your bachelor's degree within three academic years.

These studies must be registered in our study register by 31 July. In case you fail to complete 55 ECTS credits during your first academic year, you will be liable to pay the tuition fee in full thereafter. However, you will not be required to pay the tuition fee of the first academic year retrospectively. A special consideration for a scholarship extension is possible for certain reasons beyond your control (e.g., a proven medical condition).

If you complete the degree faster than in two years, your right to the scholarship expires upon the completion of your degree. In the case your studies are delayed, the scholarship usually cannot be extended. However, a separate consideration for a semester-long extension is possible for certain reasons beyond your control (e.g., a proven medical condition) or if extra time is needed to finish the thesis.

Note that the scholarship can only be postponed for those semesters or academic years for which you have been formally registered for non-attendance. According to the Universities Act, no tuition fees are collected and no scholarships are paid during non-attendance.

By ticking the box "I do not accept the above-mentioned scholarship" and signing this form, you give up your right for the entire scholarship, and you will not have a possibility to apply for it again for the study right in question.

In case your nationality or residence permit type changes to a type that exempts you from paying tuition fees, you are required to inform us about this as soon as possible via the HelpJYU form. The University will then assess your tuition fee liability status and whether you are entitled to the JYU Scholarship.

The JYU Scholarship will not be paid directly to the scholarship-recipient. Instead, the University uses the scholarship to pay for your tuition fee. Therefore, you do not receive the tuition fee scholarship money on your account.

Conditionally admitted students

Conditionally admitted students are also required to return this form by the above-mentioned deadline. However, if a conditionally admitted student accepts the study place and scholarship but does not graduate from their previous degree and/or does not submit officially certified copies of the required educational documents in time to meet the given deadline (15 July 2025 at 3:00 p.m. EEST), they will not be admitted to the University, and their study place and scholarship will be cancelled.
