### Processor(s) of personal data

#### **7. PROCESSING OF PERSONAL DATA AFTER THE RESEARCH HAS ENDED**

## 8. Rights of the data subject

### Cancellation of consent (GDPR, Article 7)

### 1. INTRACOMP Research (Intercultural and Transcultural Competence through Collaborative Cultural Expression) and invitation to participate in research

**We ask you to participate in INTRACOMP research (Intercultural and Transcultural Competence through Collaborative Cultural Expression <https://intracomp.info> )** that is funded by the European Union, and which aims to promote cultural awareness and expression in education and to enhance the inclusion and competence of children and young people. INTRACOMP particularly focuses on developing intercultural and interdisciplinary skills through arts education.

The INTRACOMP project is a three-year project developing an innovative and practical competence framework (ITC Framework) that supports the intercultural and interdisciplinary skills of individuals, groups, organizations, and systems. This framework helps identify, validate, and support the development of intercultural and transcultural competence in arts education.

The project develops and applies methods that support the use of the arts in education and assess their impacts. The INTRACOMP project will result in action recommendations that support the development of intercultural competence in education and the cultural sector. ### 3. Progress of the study

**You will take part in online survey, where you can share your insights by writing answers to suggested open-ended questions.** The questions are on the Webropol survey tool and are being displayed in English, but you are welcome to respond in your own language if you prefer. The platform is open from September 29 to October 10, 2025. You can participate at your convenience, logging in multiple times. By answering the provided Webropol survey, you give your consent for your responses to be stored and used in research reporting and scientific publications. After submitting this consent form, you will receive instructions on how to access the platform.

Participation in the study is voluntary. You can choose not to participate or stop at any time without giving a reason. The project researchers are responsible for data collection and processing. Your responses will be stored securely on the JYU Nextcloud server, following the Intracomp consortium's data agreement. The results will be used in project reports, scientific articles, and academic theses. All responses will be anonymized in publications to ensure no one can be identified.

### 4. Possible benefits from the study

### 6. Study-related costs and compensations to the subject as well as research funding

### 7. Informing about research results and research outcomes

INTRACOMP will publish its results in a wide range of formats (e.g., reports, conference presentations, academic articles, promotional materials), but no personal data collected will be publicly available. INTRACOMP will provide open access to all its publications via the INTRACOMP website (<https://intracomp.info>) and trusted academic repositories. ### 8. Insurance coverage for research subjects

The University of Jyväskylä has insurances for its activities and research subjects.
