Facts about Finland

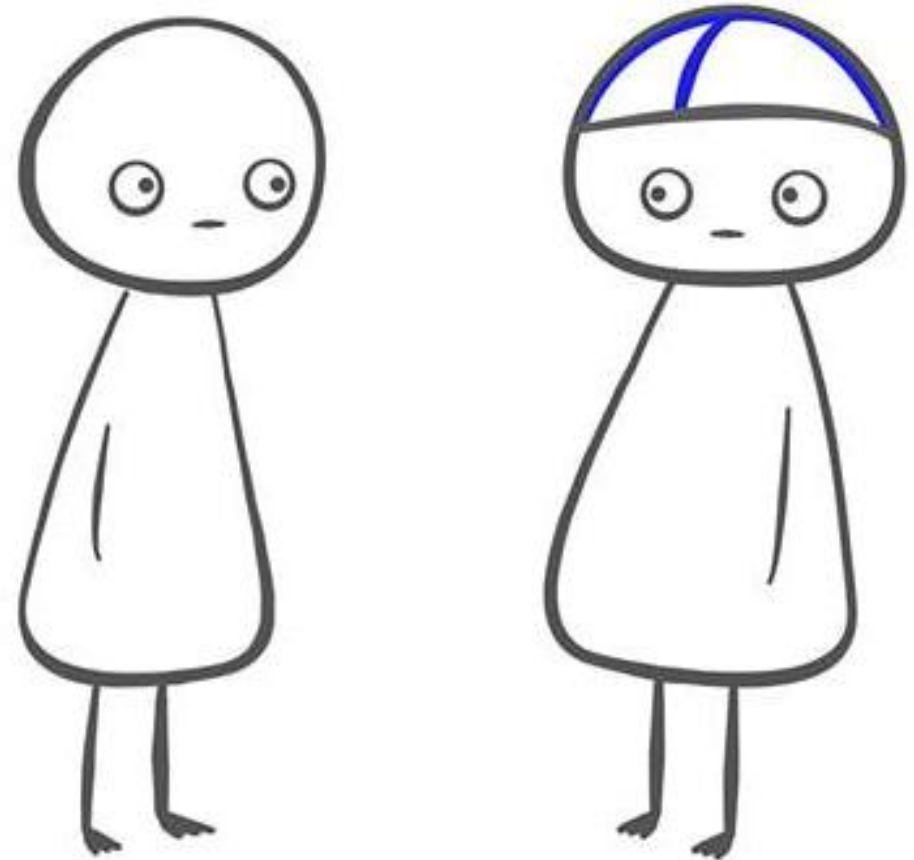
- Finland is one of the Nordic countries together with Sweden, Norway, Denmark and Iceland.
- Finland is a member of the European Union (EU) and NATO
- Finland has 5.6 million residents
- The official languages are Finnish and Swedish
- Large but sparsely populated country (70% is forest, 187,888 lakes)
- The climate is colder than in many other countries, but the weather varies significantly in different seasons.
- Finns drink the most coffee in the world.
- There are more than three million saunas in Finland.

Finnish social norms and values



- Valuing nature, everyman's rights
- Individualism, emphasis on individual responsibility
- Flat hierarchy
- Respecting own space
- Independence and self-service
- Cashless & Digital Society
- Honesty and punctuality
- Trust



Equality, rights, and responsibilities in Finland



- All discrimination on the basis of gender, age, origin, nationality, religion, political activity, disability, sexual orientation, gender identity, etc. is considered illegal
 - This zero-tolerance for discrimination applies in JYU as well
 - Everyone is responsible for creating a safe environment for others and following rules – be it on or off campus
- Finland has freedom of religion, speech, association, etc.
 - People have the right to practice their own religion or not to choose any religion
 - Men and women are equal
 - Same sex couples have the right to get married in Finland
 - Respect is a key factor regardless of your personal opinions and decisions

Finnish government and local administration

- Finland is a republic, parliamentary democracy, and a welfare state
 - The highest organs of the government are appointed in elections: Parliament of Finland and the President of the Republic
- Finland is divided into municipalities that are self-governing and collect taxes from their residents
 - With tax incomes, municipalities organize a variety of services for their residents, for example health care, public transportation, child day-care and school education
- Local state administration handle state duties in a particular area such as police, registration of population and employment offices.



Right to vote in EU & municipal elections



- In a European Parliament election, the citizens of other EU member states who have entered their names on **Finland's voting register** have the right to vote
- In a municipal election, citizens of another EU Member State as well as of Iceland and Norway have right to vote
- Also, other countries' residents who have had a municipality of residence in Finland for **at least two years** have the right to vote

Finnish Immigration Service (Migri)

Handles legality of your stay in Finland and other immigration matters



Migri: residence permits and registration of right to reside in Finland



- **Finnish Immigration Service (Migri)** is subordinate to the Ministry of the Interior in Finland and processes:
 - residence permit applications to Finland
 - applications for registering an EU citizen's right to reside in Finland
 - applications for Finnish nationality
 - refugee issues

*Citizens of a Nordic country (Denmark, Iceland, Norway or Sweden) should contact DVV to register their right of residence.

Right to reside in Finland



Non-EU / EEA citizens: your residence permit card is your proof of legally residing in Finland. Carry it with you when visiting authorities and different organisations in Finland. Please note, that the residence permit in Finland is not considered as a proof of identity and is not valid without your passport.

EU / EEA or Swiss citizens: you should register your **Right of residence** with Migri. More info: [Registration of right of residence](#) | [Maahanmuuttovirasto](#)

Right to work during studies



- **Residence permit for studies (non-EU/EEA citizens):** you are allowed to work in any field for **an average of 30 hours per week**. The number of working hours can be exceeded on some weeks, as long as the average working hours are no more than 30 hours per week at the end of the year. In other words, you may work for an average of 120 hours per month or a total of 1,560 hours per year.
 - During holidays, for example, you may work full-time in any field, provided that your average working hours are no more than 30 hours per week at the end of the year.
- If your degree requires completing an internship, the working time restrictions do not apply to it. You will need to sign an internship agreement stating that you will earn study credits for the internship.
- **EU/EEA citizens:** you have an unrestricted right to work in Finland (even if you have not yet received a decision on their application for the right to reside).

Digital and Population Data Services Agency (DVV)

Handles entering your data into the Finnish population registry and registers you as a local resident

Digital and Population Data Services Agency (DVV)



- Processes the following:
 - Applying for a **Finnish personal identity code / number** (e.g. social security number) <https://dvv.fi/en/foreigner-registration>
 - **Municipality of residence (domicile)** and permanent address in Finland <https://dvv.fi/en/municipality-of-residence>
 - Registration of the right to reside in Finland for citizens of the Nordic countries

NB! Registration of an EU citizen's right to reside in Finland by Migri is **not** the same thing as registering your place of residence in the Population Information System at the local DVV office

Municipality of residence (domicile)



Municipality of residence and the **permanent address** associated with it can be granted to those planning to live in Finland for at least **one year** and **either have a valid residence permit in Finland, or have already registered** an EU citizen's right to reside in Finland.

When you have a municipality of residence,

- you usually have the right to use the services provided by your municipality of residence (healthcare services)
- you can get a Finnish identity card (from Police) and a driving licence
- you can use services provided by authorities or receive financial benefits or subsidies.

You can get a municipality of residence even if you still live in temporary accommodations (e.g. hotel).

DVV pop-ups on campus in September

- During the campus visits of the Digital and Population Data Services Agency, you can register Jyväskylä as your municipality of residence and apply for Finnish personal identity code (if you haven't one already)
- Monday **14 September** from 9 AM to 15:45 PM
- Monday **13 October** from 9 AM to 15:45 PM

KELA - Social Insurance Institution of Finland

Responsible for the basic security of people
living in Finland in different life situations

Kela - Social Insurance Institution of Finland



If you are not a Finnish citizen and have come to Finland for study purposes, the general rule is that you cannot get financial aid from Finland. **However, you may be entitled to some Kela benefits,** provided that your move to Finland is considered permanent by KELA:

- If you come to Finland from a **EU/EEA country, Switzerland or the UK**, your stay in Finland is usually considered temporary. In that case, your country of origin is responsible for your social security benefits. You are, however, entitled to necessary medical treatment in Finland by presenting a European Health Insurance Card.
- If you come to Finland from **another country** in order to study here for at least 2 years, you can usually receive a **Kela card** and certain benefits such as reimbursements from Kela for medicine costs.

Your circumstances may change during your studies. When determining whether a person is entitled to social security coverage, Kela also takes into account possible other reasons for the stay in Finland in addition to studies (e.g. family ties, employment).

Taxation



Vero – Finland's taxation authority



- If you reside in Finland for more than **six months**, you must usually pay taxes on all your income in Finland. This also applies to the income you receive from abroad.
- In order to work in Finland, you need to apply for a **tax card** (Finnish personal identity code required)
